**AN ORDINANCE RELATING TO COUNTY ROADS (CUTTING OR DAMAGING)**

**BE IT ORDAINED BY THE PULASKI COUNTY FISCAL COURT:**

**SECTION 1.** It shall be unlawful for any person, firm, corporation, individual, or entity to wilfully cut, excavate, dig-up, traverse or otherwise damage any hard-surfaced County Road for the purpose of laying or relaying water lines, gas lines, or utility lines, without first having obtained permission of the County Judge Executive, or his/her designated representative.

**SECTION 2.** As a pre-condition to obtaining such permission, said person or entity shall post a Corporate Financial Bond payable to the Pulaski County Fiscal Court in the penal sum of TEN THOUSAND (\$10,000.00) DOLLARS, the term of which shall be twelve (12) months, conditioned upon the person or entity obtaining same restoring said road to a condition substantially similar to that which existed prior to the cut or traverse. Contractor shall have SIXTY (60) DAYS to repair cuts or damage from date of same. Said work to be inspected and approved by the appropriate Road Department official and magistrate of affected district and the County Judge Executive.

**SECTION 3.** Upon conviction of a violation of this Ordinance said offender may be fined in the Pulaski District Court in an amount not less than FIVE HUNDRED (\$500.00) DOLLARS nor more than ONE THOUSAND (\$1,000.00) DOLLARS in the discretion of the District Judge. Each day of non-compliance may be considered a separate violation for sentencing purposes.

**SECTION 4.** This Ordinance shall become effective upon signing and publication in accordance with Law.
